February 2023 Monthly Update

February is a month of tradeshows and travel for AFAN. This is our opportunity to get in front of a multitude of groups in the livestock industry in Nebraska. Our message is that livestock can be an opportunity to expand a farming operation, add economic development to a community, and an avenue to bring the next generation back to the farm or ranch. This month we literally were from coast to coast and all over Nebraska!

We attended the International Dairy Foods Association Annual Dairy Forum in Orlando, FL along with the Nebraska Dept of Economic Development. This event hosted over 1,000 high-level executives from dairy processing companies for discussions on the industry and where it was going in the future. This event allows us to talk with those executives about Nebraska and how their company can be successful here.

We attended the Nebraska Farm Bureau's Young Farmer and Rancher conference in Kearney. This event gives us a chance to network with the next generation of farmers and ranchers and help them understand the opportunities that livestock may present to them.

We presented an update and vision for the future to the Nebraska LEAD Alumni association at their annual meeting. This is a group that is well-connected in agriculture. Our message to them is to help us spread the word that AFAN is a resource for all livestock producers.

We traveled to Tulare, CA with the Grow Nebraska Dairy team to the World Ag Expo to promote the dairy industry in Nebraska. The west coast states are suffering through long-term drought, high costs, and un-friendly regulations that make running a dairy difficult. Many producers are ready to look for opportunities elsewhere.

We helped a pork producer in Antelope County do a tour of his swine finishing barns for a group of Rock County officials. The producer is hoping to build finishing barns in Rock County and just like he needs to understand the zoning rules, the county officials wanted to learn about how finishing barns operate so they can make a fact-based decision. There was great conversation and questions from both sides.

We worked with a farmer interested in building poultry barns in Banner County. He has an opportunity to participate in a high-value market for eggs and needed some

guidance on local and state regulations. We were able to provide him with the information and contacts to help him off on the right foot.

The common theme through all these events is that we must make sure all livestock producers, both in-state and out-of-state, know that the opportunities exist, that processors know their business can succeed here, and that decision-makers have the knowledge to help them make decisions, which will support growth. That is what we try to do every day; promote and grow the livestock industry in Nebraska.
